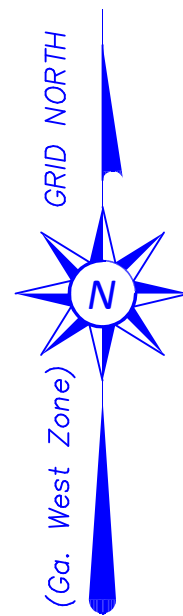
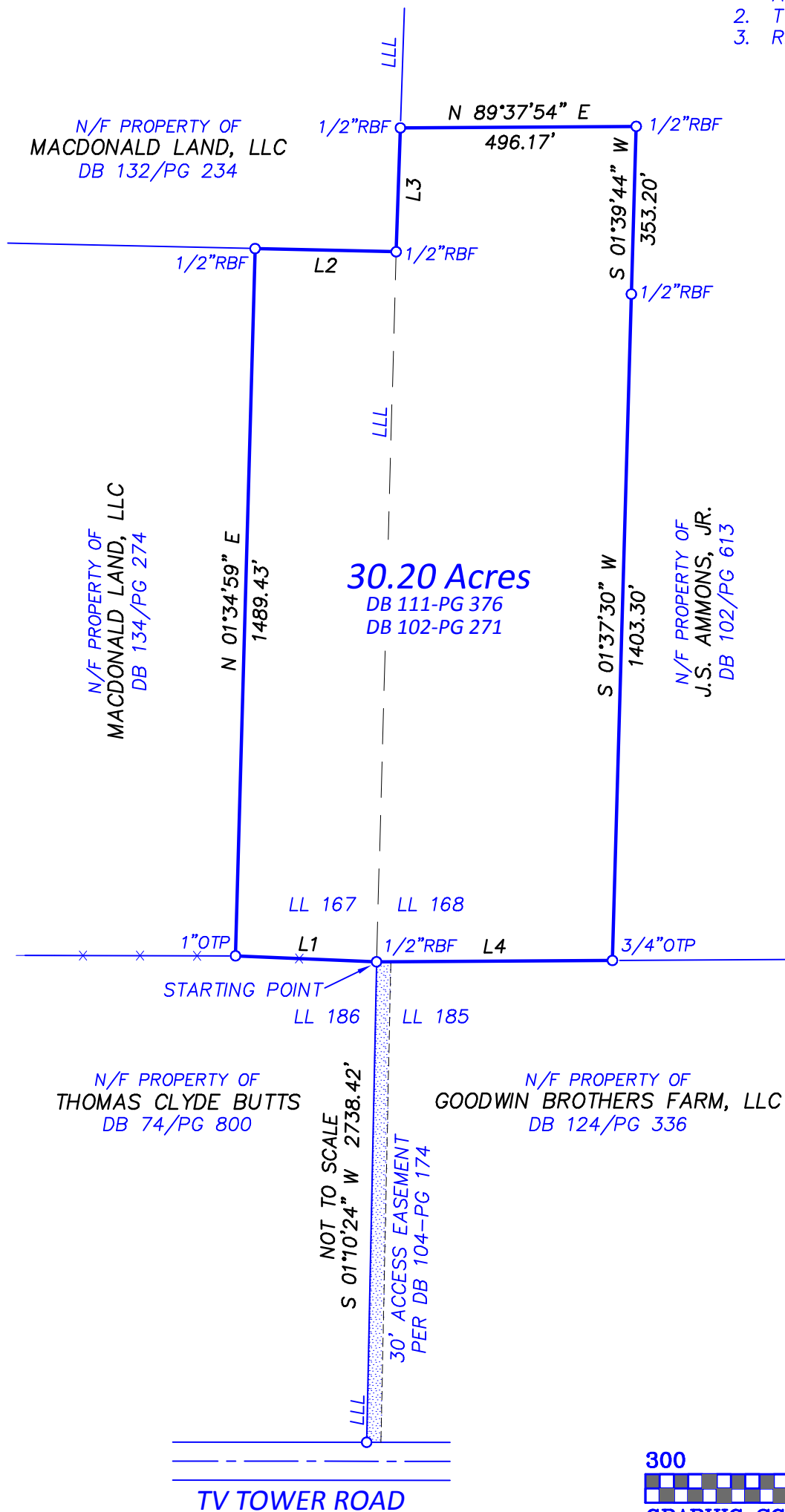

THIS SURVEY WAS MADE USING A GEOMAX ZOOM 80 ROBOTIC TOTAL STATION, MEASURING HORIZONTAL ANGLES DIRECT TO 0°00'02" AND ELECTRONICALLY MEASURING DISTANCES TO THE NEAREST 0.005'. THE FIELD DATA FROM WHICH THIS PLAT WAS PREPARED HAS AN ACCURACY OF 1' IN 19,966' AND ANGULAR ERROR OF 02" PER ANGLE POINT AND WAS NOT ADJUSTED. THIS PLAT HAS BEEN CALCULATED FOR CLOSURE AND IS ACCURATE TO WITHIN 1' IN 533315'. ESTABLISHED GRID NORTH BY GPS, USING AN ALTUS APS 3 RECEIVER, WITH eGPS REALTIME NETWORK.

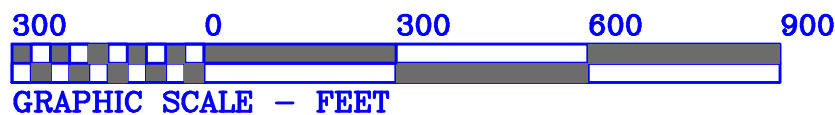
